Gloucestershire Constabulary Freedom of Information request 2023.0853

On 23/08/2023 you sent an email constituting a request under the Freedom of Information Act asking the following:

I was wondering if you could provide me with the following information for the period between August 7, 2013 and August 7, 2023, in your jurisdiction:

1. The number of arrests of anyone over the age of 85 years old
2. Reason for these arrests
3. What those arrested were charged with or were they freed without charge
4. Did those arrests result in a conviction

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Police Forces in the United Kingdom are routinely required to provide statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons the figures given relate to information from the specific recording system of Gloucestershire Constabulary and should not be used for comparison purposes with any other response you receive.

Please note that our systems are designed to record information for policing purposes and the investigation of crime and not to extract statistical information. Accordingly whilst we endeavour to extract relevant data within the time limits of the Act, any data supplied is subject to these limitations.

I can confirm a search of the Custody Recording System has been conducted for the number of authorised detentions from 07/08/2013 to 07/08/2023, this has then been

filtered for detainees aged 85 and over at the time the detention was authorised. Once the data had been located a manual review has been carried out for the details requested.

4. Details regarding any convictions is not data held by Gloucestershire Constabulary this is data which is held by the Courts.

Please note that the Constabulary only holds data in relation to the number of individuals charged/summoned for a particular offence. The ultimate outcome of these offences depends on what happens at court i.e. whether the offender is found guilty (convicted) or not. This information comes from the court results which do not come within our systems. Hence we record the detection disposals for each case but do not have the ultimate conviction data.

Therefore any information relating to the outcome of a case, the length of sentence or whether any appeal was made is not held by the constabulary, but by the HM Courts Service. Please find a link below to their website:

If you are not satisfied with this response or any actions taken in dealing with your request, you have the right to ask that we review your case under our internal procedure.
