Gloucestershire Constabulary Freedom of Information request FOI_24_0215

On 16/02/2024 you sent an email constituting a request under the Freedom of Information Act asking the following:

I would like to have the statistics for the amount of anti semitic crimes reported over the last year within the Gloucestershire Area, broken down by month and area within the statistics.

Would this be possible for the years 2018 through to the present now of January 2024.

I would also like to request the statistics for the amount of Islamophobic incidents between the years 2018 through to present of January 2024.

This should look at the breakdown of incidents each month through each year and be broken down in each area through the Gloucestershire area

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Police Forces in the United Kingdom are routinely required to provide statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons the figures given relate to information from the specific recording system of Gloucestershire Constabulary and should not be used for comparison purposes with any other response you receive.

Please note that our systems are designed to record information for policing purposes and the investigation of crime and not to extract statistical information. Accordingly whilst we endeavour to extract relevant data within the time limits of the Act, any data supplied is subject to these limitations.

A search of Gloucestershire Constabulary's Crime Recording System has been conducted for all substantiated crimes recorded between 01/01/2018 and 31/01/2024. A filter has

then been applied to identify those crimes where the Hate Crime Tag has been applied. A further filter has then been applied to identify those records where the hate crime strand is either Religion – Jewish or Religion – Muslim.

The results have then been broken down by month/year, Crime type, Local Policing Area (LPA) for each of the strands. Please see the tables below;
