Gloucestershire Constabulary Freedom of Information request FOI_24_0894

On 01/10/2024 you sent an email constituting a request under the Freedom of Information Act asking the following:

- 1 The number of rape and sexual offences recorded from September 2023 - September 2024? Can this be broken down by type of sexual offence plus age of victim and age of suspect/perpetrator
- 1a) Of those, how many were charged?

Clarification was sought from yourself in which you provided the following:

Regarding FOI 24_0894 - Can you please provide information for the following offences:

Rape
Sexual Assault

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Police Forces in the United Kingdom are routinely required to provide statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons the figures given relate to information from the specific recording system of Gloucestershire Constabulary and should not be used for comparison purposes with any other response you receive.

Please note that our systems are designed to record information for policing purposes and the investigation of crime and not to extract statistical information. Accordingly whilst we endeavour to extract relevant data within the time limits of the Act, any data supplied is subject to these limitations.

A search has been completed on the crime recording system for substantiated crimes recorded between 01.09.2023 – 30.09.2024 where the offence is one of the following:

This has resulted in a total of 1515 unique crimes. Please see the table below for the breakdown

With regards to the recorded ages, please be advised that some of the data provided may be inaccurate. The search results are reliant on the data being input to the system correctly. The only way to confirm that the age data provided is accurate would be to manually review 1,515 records.

1A) Of the total crimes identified above I can confirm that 35 resulted in the outcome of charge.

If you are not satisfied with this response or any actions taken in dealing with your request, you have the right to ask that we review your case under our internal procedure. Please note that a request for an internal review must be made within 20 working days of the response to your original request.

If you decide to request that such a review is undertaken and following this process you are still unsatisfied, you then have the right to direct your complaint to the Information Commissioner for consideration.
