Gloucestershire Constabulary Freedom of Information request FOI_24_1072

On 27/11/2024 you sent an email constituting a request under the Freedom of Information Act asking the following:

Could you please provide the following information:

1. The number of police call outs on December 25 in 2022 and 2023. Please specify:

a) The general area of the call out

b) What the call outs were for

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Police Forces in the United Kingdom are routinely required to provide statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons the figures given relate to information from the specific recording system of Gloucestershire Constabulary and should not be used for comparison purposes with any other response you receive.

Please note that our systems are designed to record information for policing purposes and the investigation of crime and not to extract statistical information. Accordingly whilst we endeavour to extract relevant data within the time limits of the Act, any data supplied is subject to these limitations.

A search has been conducted of the Incident Recording System for the number of incidents recorded on both 25/12/2022 and 25/12/2023. A filter has been applied to identify records where it has been documented that at least one police resource has attended. Please see the tables below for the requested data.
