Gloucestershire Constabulary Freedom of Information request FOI_25_0844

On 19/08/2025 you sent an email constituting a request under the Freedom of Information Act asking the following:

A list of all police officers who are currently suspended on full pay, including their rank, the reason for their suspension, and the number of days they have been suspended

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Police Forces in the United Kingdom are routinely required to provide statistics to government bodies, and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons the figures given relate to information from the specific recording system of Gloucestershire Constabulary and should not be used for comparison purposes with any other response you receive.

Please note that our systems are designed to record information for policing purposes and the investigation of crime and not to extract statistical information. Accordingly, whilst we endeavour to extract relevant data within the time limits of the Act, any data supplied is subject to these limitations.

The below table shows police officers suspended along with the number of days suspended up to the date of 16/09/2025. For the avoidance of doubt, the data has been supplied to the date of 16/09/2025 in line with the original dates of the request.
