Gloucestershire Constabulary Freedom of Information request FOI_25_0060

On 17/01/2025 you sent an email constituting a request under the Freedom of Information Act asking the following:

I am a producer for ITV News and am writing to you under the Freedom of Information Act 2000 to request the following information:

1. The number of transgender hate crimes reported per year from 2022 - 2024 (inclusive).
2. The number of prosecutions for transgender hate crimes per year from 2022 - 2024 (inclusive).
3. The number of transgender hate crimes that resulted in no further action, reported per year from 2022 - 2024 (inclusive).
4. The number of successful prosecutions for transgender hate crimes per year from 2011 – 2021 (inclusive)
5. The number of transgender police officers and their proportion as a percentage of all police officers, reported per year from 2011 - 2021 (inclusive).
6. The details of any police policies or initiatives to increase the detection and/or prosecution of hate crimes against transgender people.
7. The details or any police policies or initiatives to increase the trust the transgender community have in the police.

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Police Forces in the United Kingdom are routinely required to provide statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons the figures given relate to

information from the specific recording system of Gloucestershire Constabulary and should not be used for comparison purposes with any other response you receive.

Please note that our systems are designed to record information for policing purposes and the investigation of crime and not to extract statistical information. Accordingly whilst we endeavour to extract relevant data within the time limits of the Act, any data supplied is subject to these limitations.

I can confirm a search has been conducted of our Crime Recording System for all substantiated crimes recorded between 01/01/2022 and 31/12/2024 where the hate tags of 'Transphobic' and 'Gender Identity – Trans' have been applied. This has also been broken down by outcome.

4. Please note that the Constabulary only holds data in relation to the number of individuals charged/summoned for a particular offence. The ultimate outcome of these offences depends on what happens at court i.e. whether the offender is found guilty (convicted) or not. This information comes from the court results which do not come within our systems. Hence we record the detection disposals for each case but do not have the ultimate conviction data.

Therefore any information relating to the outcome of a case, the length of sentence or whether any appeal was made is not held by the constabulary, but by the HM Courts Service. Please find a link below to their website:
