Gloucestershire Constabulary Freedom of Information request FOI_25_0274

On 07/03/2025 you sent an email constituting a request under the Freedom of Information Act asking the following:

I am writing to request information under the Freedom of Information Act 2000 regarding speed enforcement activity in the following locations:

Windyridge Road

Tommy Taylors Lane

Tewkesbury Road (within Cheltenham)

Swindon Road (within Cheltenham)

I would be grateful if you could provide the following data for the past three years (or the most recent period available):

1. Locations of speed traps (both mobile and fixed) at these locations.
2. The number of vehicles recorded exceeding the speed limit at these locations.
3. The highest recorded speeds at these locations during enforcement operations.
4. The number of Fixed Penalty Notices (FPNs) or prosecutions resulting from speed enforcement in this area.
5. Any available data on the times and dates when enforcement took place.
6. Any reports or assessments on the effectiveness of speed enforcement measures in

this area.

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Following receipt of your request, I can confirm that your request has been sent to the relevant department who has confirmed the following:

1. There are no 'Speed Traps' however, Gloucestershire Constabulary do have a speed enforcement site on Tommy Taylors Lane.
There is Community Speed Watch with no speed enforcement sites at the locations of Windyridge Road and Swindon Road, Cheltenham.
There is no sites of any sorts within the location of Tewkesbury Road, Cheltenham.

2. 18 Vehicles have been caught exceeding the speed limit.

3. The highest speed recorded at Tommy Taylors Lane was 40mph.

4. 6 Fixed Penalty Tickets were issued.
