Gloucestershire Constabulary Freedom of Information request FOI_25_0289

On 12/03/2025 you sent an email constituting a request under the Freedom of Information Act asking the following:

To whom it may concern,
Under the Freedom of Information Act 2000, I request the following information:

How many dog attacks were reported in the year-to-date, month by month? Please categorise the dogs that attacked into dog breeds and include the age of the dog and whether they belonged to an owner or not.

How many dogs reoffended or were reported as being dangerous prior to an attack?

How many dog attacks required medical or veterinary attention?

What were the reported locations of attacks?

What were the ages and gender of the victims of the attacks?

How many dogs were put down or given to an animal shelter/ disowned following an attack?

What action - if any - was taken against the dog owners or anyone responsible for them at the time of the attack?

I also request the same information for the following years: 2023/24; 2022/23; 2021/22.

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary may hold some relevant information.

When an Individual contacts the police and it is deemed to be a police matter, an incident will be created on the Incident Recording System. Please note that the word "incident" in Gloucestershire Constabulary's terminology refers to a type of record, not the event as a whole. If an offence is being reported (rather than a missing person for example) the "incident" will be assessed to determine if the offence falls within the Home Office Crime Recording Rules. If that incident is deemed to fall within the counting rules, a "crime" will be recorded on the Crime Recording System.

Please note that the Incident Recording System is largely a free text entry system and does not record information in as much detail as the Crime Recording System and therefore its reporting function is limited.

Unfortunately there is no way of electronically searching for the information you have requested. The Incident Recording System does not have any way of identifying dog attacks, the breeds and the ages of the dogs, other than where the word is recorded within the report, therefore in order to ascertain incidents that relate to such locations, a manual review of all incidents for the years requested would be required. Given that the Constabulary records approximately 500 incidents per day, this would clearly take far longer than the 18 hours prescribed by Section 12 of the Freedom of Information Act

Please see below for suggestions on how you may be able to refine your request to come within the cost constraints of Section 12 of the Act.

Section 17(5) of the Freedom of Information Act 2000 requires Gloucestershire Constabulary, when refusing to provide information (because the information is exempt) to provide you the applicant with a notice which: (a) states the fact, (b) specifies the exemption in question and (c) states (if not otherwise apparent) why the exemption applies.

In relation to your request Section 12 applies.

Section 12(1) – Fee Regulations states:

Section 1(1) of the Act does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit. (As detailed in the Data Protection and Freedom of Information Fees Regulations of 2004)

The appropriate limit at the moment is £450 calculated at an hourly rate of £25 per hour for all staff time incurred in:

- i. Determining whether information is held
- ii. Locating it
- iii. Retrieving it
- iv. Extracting the information to be disclosed from the other information.

In accordance with the Act, this letter represents a Refusal Notice for your request.

Under Section 16 duty to assist, as search can be conducted of the Crime Recording System for the offence of '008/21 - Owner or person in charge allowing dog to be dangerously out of control in any place in England and Wales (whether or not in a public place) injuring any person or assistance dog.' This search can also include the breeds of the dogs where it has been recorded.

Regarding the rest of the questions we can inquire with the Dog Legislation Officers as to information which is held regarding reports of Dangerous Dogs.

If this would assist, please submit a new FOI request.

If you are not satisfied with this response or any actions taken in dealing with your request, you have the right to ask that we review your case under our internal procedure. Please

note that a request for an internal review must be made within 20 working days of the response to your original request.

If you decide to request that such a review is undertaken and following this process you are still unsatisfied, you then have the right to direct your complaint to the Information Commissioner for consideration.
