Gloucestershire Constabulary Freedom of Information request FOI_25_0295

On 13/03/2025 you sent an email constituting a request under the Freedom of Information Act asking the following:

I am contacting you to request information under the Freedom of Information Act.

Please could you confirm:

- a) How many incidents of street harassment were reported to your force in the years 2020, 2021, 2022, 2023, 2024 respectively;
- b) How many of the alleged victims for each year were male and how many were female;
- c) How many of the alleged perpetrators for each year were male and how many were female.

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary may hold some relevant information.

When an Individual contacts the police and it is deemed to be a police matter, an incident will be created on the Incident Recording System. Please note that the word "incident" in Gloucestershire Constabulary's terminology refers to a type of record, not the event as a whole. If an offence is being reported (rather than a missing person for example) the "incident" will be assessed to determine if the offence falls within the Home Office Crime Recording Rules. If that incident is deemed to fall within the counting rules, a "crime" will be recorded on the Crime Recording System.

Please note that the Incident Recording System is largely a free text entry system and does not record information in as much detail as the Crime Recording System and therefore its reporting function is limited.

There is no specific recording code for Harassment within the Incident Recording System, therefore the only way to determine if information relevant to your request is held is to manually review all incidents recorded within the date range specified. As the

Constabulary records approximately 500 incidents per day, this would which would obviously take far longer than the 18 hours prescribed by the Freedom of Information Act.

Section 17(5) of the Freedom of Information Act 2000 requires Gloucestershire Constabulary, when refusing to provide information (because the information is exempt) to provide you the applicant with a notice which: (a) states the fact, (b) specifies the exemption in question and (c) states (if not otherwise apparent) why the exemption applies.

In relation to your request Section 12 applies.

Section 12(1)– Fee Regulations states:

Section 1(1) of the Act does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit. (As detailed in the Data Protection and Freedom of Information Fees Regulations of 2004)

The appropriate limit at the moment is £450 calculated at an hourly rate of £25 per hour for all staff time incurred in:

- i. Determining whether information is held
- ii. Locating it
- iii. Retrieving it
- iv. Extracting the information to be disclosed from the other information.

In accordance with the Act, this letter represents a Refusal Notice for your request.

Section 16 of the Freedom of Information Act, provides the opportunity to assist the applicant with any suggestions or variation that may allow a search to be undertaken within the cost constraints of Section 12 of the Act.

I confirm that the Constabulary could provide the following:

A search of the Crime Recording System could be conducted to identify the number of substantiated crimes recorded where the offence falls under the Home Office Sub-Classification of Stalking and Harassment. Once these have been identified, we are then able to provide a breakdown of the gender of the victim and offender.

If this would be of use to you, you can resubmit your request on this basis.

If you are not satisfied with this response or any actions taken in dealing with your request, you have the right to ask that we review your case under our internal procedure. Please note that a request for an internal review must be made within 20 working days of the response to your original request.

If you decide to request that such a review is undertaken and following this process you are still unsatisfied, you then have the right to direct your complaint to the Information Commissioner for consideration.
