Gloucestershire Constabulary Freedom of Information request FOI_25_0583

On 05/06/2025 you sent an email constituting a request under the Freedom of Information Act asking the following:

I am writing to you under the Freedom of Information Act 2000 to request the following information on lost and stolen wrist watches.

1. How many watches were recorded as stolen in 2023 and 2024? Please provide figures for each year.
2. What was the combined value of these watches? Please provide figures for each year.
3. What number of watches recorded as stolen in 2023 and 2024 were recovered?
4. What number of watches reported stolen in 2023 and 2024 involved some form of violence against the owner/person wearing the watch?
5. What number of watches reported stolen in 2023 and 2024 have resulted in the fatality of the victim?

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Police Forces in the United Kingdom are routinely required to provide statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons the figures given relate to information from the specific recording system of Gloucestershire Constabulary and should not be used for comparison purposes with any other response you receive.

Please note that our systems are designed to record information for policing purposes and the investigation of crime and not to extract statistical information. Accordingly whilst we endeavour to extract relevant data within the time limits of the Act, any data supplied is subject to these limitations.

Please note that due to recording practices there may be some anomalies within the data.

A search of the Crime Recording System has been conducted to identify all crimes recorded between 01/01/2023 and 31/12/2024 where there is a property item of "watch" recorded as stolen/recovered.
