Gloucestershire Constabulary Freedom of Information request FOI_25_0696

On 15/07/2025 you sent an email constituting a request under the Freedom of Information Act asking the following:

Under the Freedom of Information Act 2000, I kindly request the following data for analytical purposes.

Please provide numerical data only, from 1st April 2017 to 1st April 2025, concerning violent and sexual offences recorded within:

- The Gloucestershire Authority, as defined by ONS LTLA Code, E07000078, E07000079, E07000080, E07000081, E07000082, E07000083, E06000025.
- And a 1-mile radius surrounding the codes

Specifically, I request:

1. Total number of offences for each year, broken down by:

o **Violent Crime Categories**, e.g.: Violence Against the Person, Assault with Injury, Homicide, etc.

o **Sexual Offence Categories**, e.g.: Rape, Sexual Assault, Sexual Activity with a Child, etc.

2. Suspect demographics (if available) for these crimes:

o Gender

o Age group (e.g., under 18, 18–24, 25–34, 35–49, 50–64, 65+)

o Ethnicity, using the self-defined ethnicity classification

Notes to Aid Processing

- I do not require victim information, personal data, or any identifying details.
- If the 1-mile buffer data is not readily available, please provide data for the LTLA alone, and indicate whether the radius expansion is feasible.
- If this request exceeds the appropriate time/cost limits under the Act, I am happy to refine it further.

Please let me know if you require any clarification

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Police Forces in the United Kingdom are routinely required to provide statistics to government bodies, and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons the figures given relate to information from the specific recording system of Gloucestershire Constabulary and should not be used for comparison purposes with any other response you receive.

Please note that our systems are designed to record information for policing purposes and the investigation of crime and not to extract statistical information. Accordingly, whilst we endeavour to extract relevant data within the time limits of the Act, any data supplied is subject to these limitations.

A search was conducted of the Constabulary's crime recording database for offences under the violent crime & sexual offence categories between 1st April 2017 to 1st April 2025. This information was broken down, following your clarification by e-mail, by local policing area (LPA), as well as the specific Home Office categories. Please see the separate PDF (25_0696 Question 1 Offence Data) for the results of this search. For Q2 of your request, the data was filtered to locate suspect information and then sorted by gender, age group and ethnicity. This information can be found below.
