Gloucestershire Constabulary Freedom of Information request FOI_25_0778

On 05/08/2025 you sent an email constituting a request under the Freedom of Information Act asking the following:

Total number (and monetary amount) of fines issued for speeding, over a 12 month period [between June 2024 - June 2025].

Broken down by age of driver if possible.

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Police Forces in the United Kingdom are routinely required to provide statistics to government bodies, and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons the figures given relate to information from the specific recording system of Gloucestershire Constabulary and should not be used for comparison purposes with any other response you receive.

Please note that our systems are designed to record information for policing purposes and the investigation of crime and not to extract statistical information. Accordingly, whilst we endeavour to extract relevant data within the time limits of the Act, any data supplied is subject to these limitations.

The tables below denote the number of offences recorded between 01/06/2024 and 31/05/2025 that resulted in fixed penalty notices being issued, prosecutions and driver retraining. To reduce the possibility of identifying individuals, some individual ages have been grouped together in a band.
