Gloucestershire Constabulary Freedom of Information request FOI_25_1015

On 20/10/2025 you sent an email constituting a request under the Freedom of Information Act asking the following:

For the date range 1st January 2022 to 30th September 2025 inclusive, please provide:

1. The total number of racially- or religiously-aggravated hate crimes reported to your force
2. The total number of racially-motivated hate crimes reported to your force
3. The number of racially-motivated hate crimes reported to your force broken down by ethnicity or perceived ethnicity of the alleged victim
4. The total number of religiously-aggravated hate crimes reported to your force
5. The number of religiously-aggravated hate crimes reported to your force, broken down by religion or perceived religion of the alleged victim

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Police Forces in the United Kingdom are routinely required to provide statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons the figures given relate to information from the specific recording system of Gloucestershire Constabulary and should not be used for comparison purposes with any other response you receive.

Please note that our systems are designed to record information for policing purposes and the investigation of crime and not to extract statistical information. Accordingly whilst we endeavour to extract relevant data within the time limits of the Act, any data supplied is subject to these limitations.

A search of the Crime Recording System has been conducted to identify all substantiated crimes where the hate crime tag for race and/or religion has been added to the record.

The results have been broken down by month/year, hate strand and ethnicity.

If you are not satisfied with this response or any actions taken in dealing with your request, you have the right to ask that we review your case under our internal procedure. Please note that a request for an internal review must be made within 20 working days of the response to your original request.

If you decide to request that such a review is undertaken and following this process you are still unsatisfied, you then have the right to direct your complaint to the Information Commissioner for consideration.
