Gloucestershire Constabulary Freedom of Information request FOI_25_1052

On 30/10/2025 you sent an email constituting a request under the Freedom of Information Act asking the following:

Could you please provide information on your performance in tackling speeding in terms of fines issued/prosecutions or any actual type of penalty (ie ignoring speedwatch's 'stiff letters' and other trivialising responses)

I would like this broken down by speed limit penalty category (20mph, 30mph, 40 mph, etc) and ideally by each month since January 2018. However if the monthly breakdown is too time-consuming for an FOI then by year would be fine.

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Following searches undertaken by one of Gloucestershire Constabulary's subject experts, the following information can be shared:

In addition, please also note the following information:

In 2023, further to the totals shared: 5192 were cancelled, 15439 (of which 2196 courses rejected) complied; conditional offer, 23151 complied; course offer and 2660 were sent to court.

In 2024, further to the totals shared: 2207 were cancelled, 12917 (of which 1638 courses rejected) complied; conditional offer, 20260 complied; course offer and 3221 were sent to court.

In 2025, further to the totals shared: 5160 were cancelled, 18850 (of which 2526 courses rejected) complied; conditional offer, 29261 complied; course offer and 2219 were sent to court.

If you are not satisfied with this response or any actions taken in dealing with your request, you have the right to ask that we review your case under our internal procedure. Please note that a request for an internal review must be made within 20 working days of the response to your original request.

If you decide to request that such a review is undertaken and following this process you are still unsatisfied, you then have the right to direct your complaint to the Information Commissioner for consideration.
