Gloucestershire Constabulary Freedom of Information request FOI_ 25_1170

On 03/12/2025 you sent an email constituting a request under the Freedom of Information Act asking the following:

Q1) Please can you state for offences recorded by your force, the number in which the crime report text (described as modus operandi reports by many forces) contains a mention of "onlyfans" in each of the following calendar years. Please also state the type of crime and outcome (i.e. no further action, withdrawn, charged etc.) Please provide this in .csv format.

- i) 2024
- ii) 2025

Q2) Please can you provide a redacted copy of the free text crime reports for these offences recorded by your force between July 2024 and July 2025.

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Police Forces in the United Kingdom are routinely required to provide statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons the figures given relate to information from the specific recording system of Gloucestershire Constabulary and should not be used for comparison purposes with any other response you receive.

Please note that our systems are designed to record information for policing purposes and the investigation of crime and not to extract statistical information. Accordingly whilst we endeavour to extract relevant data within the time limits of the Act, any data supplied is subject to these limitations.

A search was completed for crimes recorded between 01/01/2024 and 31/12/2025 this has then been filtered to show only crimes that have MO freetext that include 'Only Fans', 'OnlyFans' and 'OnlyFans.com'. This has produced the below data:

1	THE VICTIM IS A _____ AT AROUND 1200HRS THE VICTIM HAS RECIEVED ABUSIVE AND THREATENING MESSAGES OVER SNAPCHAT. THE SUSPECT HAS THREATENED TO ATTEND THE ADDRESS THAT THE VICTIM RESIDES AT AND SMASH IT UP. THE SUSPECT HAS ALSO SAID IN MESSAGES 'HOW IS _____' (_____) AND 'WHO LIVES AT _____'. SUSPECT HAS ALSO SENT THAT THEY WERE GOING TO FIND THE VICTIM AND DO 'SOMETHING' TO HER. THE SUSPECT ASKED IF THE VICTIM WAS ON 'ONLY FANS' AND ASKED FOR NUDE PICTURES.
2	SUSPECT AND VICTIM WORK TOGETHER. SUSPECT HAS MADE AN ONLYFANS AND INSTAGRAM ACCOUNT USING VICTIM'S NAME AND PROFILE PICTURE. SUSPECT HAS BEEN FOLLOWING VICTIM'S FAMILY AND YOUNGER COUSINS ON SOCIAL MEDIA. SUSPECT HAS GIVEN VICTIM'S PERSONAL INFORMATION TO STRANGERS ON DATING APPS. THE MALES ARE THEN CONTACTING VICTIM. CAUSING ALARM AND DISTRESS.
3	VICTIM AND SUSPECT KNOW OF EACH OTHER. SUSPECT HAS DOWNLOADED AND SHARED INTIMATE IMAGES AND VIDEOS OF THE VICTIM FROM A PAID SUBSCRIPTION WEBSITE. IMAGES AND VIDEOS WERE WATERMARKED ON 'ONLY FANS'. SUSPECT HAS THEN SHARED THE IMAGES AND VIDEOS ON ANOTHER WEBSITE WITHOUT THE CONSENT OF THE VICTIM. THIS HAS CAUSED THE VICTIM DISTRESS AS THE IMAGES AND VIDEOS ARE HISTORIC AND WERE NOT REMOVED BY THE VICTIM.
4	SUSPECT IS THE VICTIMS EX-PATNER. WHEN SUSPECT AND VICTIM SEPARATED SUSPECT CHANGED ALL THE LOCKS ON THE DOORS LEAVING VICTIM AND THEIR CHILD HOMELESS. SUSPECT HAS CALLED/THREATENED SOCIAL SERVICES AND COURT MANY TIMES, STATING THAT VICTIM IS NOT A FIT MOTHER AND LOWERING HER SELF-CONFIDENCE. SUSPECT MADE HER HAVE A BOOB JOB, WOULD WANT HER TO ONLY DRESS IN A FEMININE WAY, MAKE HER FEEL LIKE A SEXUAL OBJECT. SUSPECT CREATED VICTIM AN ONLY FANS PLATFORM THAT HE WOULD MANAGE AND PIMP HER ON, MAKE HER HAVE THREESOMES AND PRESSURED HER TO DO SEXUAL ACTS. SUSPECT REFUSES TO ENGAGE IN HANDOVER OF CHILD UNLESS IT IS DONE SO ON HER PROPERTY WITH EITHER HIMSELF OR HIS MOTHER. SUSPECT HAS MADE THE VICTIM FEEL ISOLATED FROM FAMILY AND FRIENDS. SUSPECT HAS ALSO THREATENED THE VICTIM WITH PHYSICAL AND SEXUAL VIOLENCE AND HAS RECENTLY BEEN MESSAGING HER AND TURNING UP UNANNOUNCED.
5	VICTIM HAS RECEIVED A WHATSAPP MESSAGE FROM AN UNKNOWN PERSON. THE WHATSAPP ACCOUNT HAS BEEN SET UP TO LOOK LIKE THE VICTIM AND HAVE GOT PHOTOS OF THE VICTIM WHICH THEY ARE THREATENING TO PUBLICISE UNLESS THE VICTIM PAYS THEN MONEY. VICTIM IS ALSO RECEIVING MESSAGES FROM ONLY FANS WITH A SET UP CODE.
6	VICTIM AND SUSPECT ARE IN A RELATIONSHIP. VICTIM HAS BEEN PHYSICALLY AND MENTALLY ABUSED BY SUSPECT FOR MONTHS.SUSPECT HAS BEEN STRANGLING HIM TILL HE WENT PURPLE. SHE HAS BEEN CUTTING HIM. SHE PUT A KNIFE TO HIS THROAT. VICTIM PUSHED HER OFF AND SHE CUT HER FACE. SUSPECT HAS PUT ON SOCIAL MEDIA THAT HE IS ABUSING HER. SUSPECT HAS THREATENED TO KILL HERSELF, RUIN HIS LIFE AND MAKE ALLEGATIONS OF RAPE IF VICTIM TRIES TO LEAVE HER. _____ THE SUSPECT HAS BEEN POSITNG EXPLICIT VIDEOS OF VICTIM EJACULATING ON HER FACE ON ONLY FANS. THE VICITMS FACE IS NOT IN THIS VIDEO AND HE ONLY KNOWS ABOUT THIS AS HIS BROTHER SCREEN RECORDED AND SENT IT TO VICTIM.
7	THE VICTIM REPORTS THAT SHE HAS FOUND OUT THE SUSPECT HAS BEEN POSTING EXPLICIT VIDEOS OF THE PAIR HAVING SEX ONTO ONLY FANS. THE SUSPECT HAS ALSO MADE AN INSTAGRAM TO PROMOTE THE ONLY FANS, THE VICTIM FOUND THS AND COMMENTED 'HOW DARE

	YOU' TO WHICH THE SUSPECT BLOCKED HER FROM THE INSTAGRAM PAGE AND THE ONLY FANS. VICTIM WANTS THE VIDEOS TAKEN DOWN.
8	SUSPECT IS THE VICTIMS SON WHOM HAS ASSISTED THE VICTIM WITH THE BUSINESS ACCOUNT DUE TO COMPUTER LITERACY. ON PREVIOUS OCCASIONS THE VICTIM HAS ALLOWED ACCESS TO THE FINANCES TO ASSIST THE VICTIM. RECENTLY VICTIM HAS BEEN CONTACTED BY THE BANK REGARDING UNUSUAL ACTIVITY WHICH HAS LED THE VICTIM TO FIND THAT THE SUSPECT HAS BEEN UTILISING THE VICTIMS ACCOUNT WITHOUT THEIR PERMISSION. SUSPECT HAS PURCHASED ITEMS FROM AMAZON WITH VICTIMS BANK CARD AND USED IT ON ONLYFANS. FURTHER INFORMATION - AROUND 5 YEARS AGO THE SUSPECT STRANGLED VICTIM UNTIL HE PASSED OUT. VICTIM DID NOT REPORT THIS TO THE POLICE AT THE TIME. SUSPECT HAS PREVIOUSLY KNOCKED VICTIMS TOOTH OUT, KICKED AND PUNCHED VICTIM IN THE FACE, GRABBED VICTIM BY THE EARS, BIT VICTIM AND THREW THEM AROUND LIKE A DOG TOY.
9	SUSPECT AND VICTIM ARE EX-PARTNERS. DURING THE RELATIONSHIP SUSPECT HAD NON-CONSENSUAL SEXUAL INTERCOURSE WITH VICTIM ON MORE THAN ONE OCCASION, VICTIM REPEATEDLY SAID "NO" AND SUSPECT CONTINUED. SUSPECT HAS ALSO USED EMOTIONAL GUILT OR ANGER TO COERCE VICTIM INTO HAVING SEXUAL ACTIVITY WITH HIM. SUSPECT IS IN POSSESSION OF INTIMATE IMAGES/VIDEOS OF VICTIM WITHOUT HER CONSENT. VICTIM HAS ASKED SUSPECT TO DELETE THEM AND SUSPECT ADMITTED HE DID NOT DELETE THEM. SUSPECT HAS CREATED AN ONLYFANS ACCOUNT USING INTIMATE IMAGES OF VICTIM WIHTOUT HER CONSENT. SUSPECT HAS USED SILENCE, WITHDRAWAL AND EMOTIONAL MANIPULATION TO CONTROL VICTIM'S BEHAVIOUR. SUSPECT THREATENS TO LEAVE TO INFLUENCE VICTIM'S DECISIONS, WILL IGNORE VICTIM'S MESSAGES AND LIE ABOUT HIS WHEREABOUTS.
10	SUSPECT HAS BEEN SENDING VICTIM MESSAGES ON SOCIAL MEDIA ASKING FOR NUDES IN EXCHANGE FOR PAYMENT. THEY HAVE ALSO SENT VICTIM HER OWN NUDES SAVED FROM HER OLD ONLYFANS ACCOUNT. VICTIM HAS BLOCKED SUSPECT AND THEY JUST CREATE NEW ACCOUNTS, MOST RECENTLY SUSPECT IS CREATING ACCOUNTS IN VICTIM'S ANME USING HER OLD ONLYFANS PROFILE PICTURE. SUSPECT HAS MESSAGED VICITM ON SNAPCHAT, TIKTOK, INSTAGRAM AND MOST OTHER SOCIAL MEDIA SITES.
11	VICTIM MET SUSPECT ON A DATING WEBSITE AND MET WITH HIM TWICE. VICTIM AGREED TO A VIDEO OF THEM HAVING SEX ON THE UNDERSTANDING IT WAS FOR PERSONAL USE. SUSPECT HAS POSTED THE VIDEO ON A PAID SUBSCRIPTION APP CALLED "ONLY FANS" AND VICTIM WAS MADE AWARE OF THIS BY FRIENDS.
12	SUSPECT HAD ASKED FOR A NAKED IMAGE OF THE VICTIM AND VICTIM SAID THEY WOULD BE OBLIGED THROUGH ONLY FANS. SUSPECT HAS THEN SENT A NAKED IMAGE TO THE VICTIM AND VICTIM HAD RECOGNISED THAT THE NAKED IMAGE WAS OF HER. CAUSING ALARM AND DISTRESS.
13	VICTIM AND A FRIEND HAVE MET UP WITH THE SUSPECT TO CONFRONT HER OVER SOME MESSAGES THAT HAVE BEEN SENT. THEY HAVE MET AT A PUB WHERE THE SUSPECT HAS BROUGHT DRINKS FOR THE VICTIM AND HER FRIEND. THEY HAVE THEN GONE TO ANOTHER PUB AND CONTINUED DRINKING BEFORE GOING BACK TO THE SUSPECT'S HOUSE. THE SUSPECT HAS ASKED IF THE VICTIM AND FRIEND WANT TO WEAR SOME LINGERIE BEFORE THEY HAVE ENGAGED IN A THREESOME. THIS ACT WAS FILMED BY THE SUSEPCT'S BOYFRIEND AND INITALLY JUST SHARED IN A GROUP CHAT WHICH VICTIM WAS HAPPY WITH. THIS VIDEO HAS SUBSEQUENTLY BEEN SHARED ON TWITTER, INSTAGRAM AND ONLYFANS CAUSING THE VICTIM A GREAT DEAL OF STRESS AND FEELING VIOLATED.
14	VICTIM HAS STATED THAT SUSPECT HAS TAKEN HER PHOTOS FROM ONLY FANS AND DISTRIBUTED THEM TO HER COLLEAGUES AT THE _____ WITHOUT HER PERMISSION AND SHE BELIVED THAT THEY COULD NO LONGER BE ACCESSED.

If you are not satisfied with this response or any actions taken in dealing with your request, you have the right to ask that we review your case under our internal procedure. Please note that a request for an internal review must be made within 20 working days of the response to your original request.

If you decide to request that such a review is undertaken and following this process you are still unsatisfied, you then have the right to direct your complaint to the Information Commissioner for consideration.
