Gloucestershire Constabulary Freedom of Information request FOI_26_0077

On 19/01/2026 you sent an email constituting a request under the Freedom of Information Act asking the following:

1) The total number of Disclosure Requests made under the Domestic Violence Disclosure Scheme (also known as "Clare's Law") during the period 1st January 2025 up to and including 31st December 2025 by gender, age, & ethnicity.

For your ease of reference, please provide the details for the "Person at Risk" i.e. the person for whom the enquiry has been made by directly and/or on behalf of.

2) During the period 1st January 2025 up to and including 31st December 2025 please provide the gender of the person making the enquiry regarding their current partner and/or the person making the enquiry directly on behalf of the "Person at Risk."

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Police Forces in the United Kingdom are routinely required to provide statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons the figures given relate to information from the specific recording system of Gloucestershire Constabulary and should not be used for comparison purposes with any other response you receive.

Please note that our systems are designed to record information for policing purposes and the investigation of crime and not to extract statistical information. Accordingly whilst we endeavour to extract relevant data within the time limits of the Act, any data supplied is subject to these limitations.
