Gloucestershire Constabulary Freedom of Information request FOI_26_0213

On 23/02/2026 you sent an email constituting a request under the Freedom of Information Act asking the following:

Please provide a map detailing your divisions and every station across the force area.

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Section 17 of the Freedom of Information Act 2000 requires Gloucestershire Constabulary, when refusing to provide information (because the information is exempt) to provide you the applicant with a notice which: (a) states the fact, (b) specifies the exemption in question and (c) states (if not otherwise apparent) why the exemption applies.

The following exemptions apply:

Section 21 – Information reasonably accessible by other means

The above exemption is absolute and class-based and therefore no Public Interest Test or Harm Test is required.

The information that you have requested is already reasonably accessible to you by other means and is therefore exempt by virtue of Section 21 of the Freedom of Information Act 2000. Gloucestershire Constabulary are required to make certain information available to the public as part of a publication scheme.

The information you have requested is available via the [Gloucestershire Constabulary](http://www.gloucestershire.police.uk) website, by searching for each of the Gloucestershire local policing areas listed below and by accessing the 'stations, contact points and offices' tab for a map and list of stations.

- Gloucester
- Cheltenham
- Stroud
- Tewkesbury
- Forest of Dean
- Cotswolds

Please note, police officers can be dispatched from anywhere in the Gloucestershire area and are not based from specific police stations.

If you are not satisfied with this response or any actions taken in dealing with your request, you have the right to ask that we review your case under our internal procedure. Please note that a request for an internal review must be made within 20 working days of the response to your original request.

If you decide to request that such a review is undertaken and following this process you are still unsatisfied, you then have the right to direct your complaint to the Information Commissioner for consideration.
