Gloucestershire Constabulary Freedom of Information request FOI_26_0276

On 11/03/2026 you sent an email constituting a request under the Freedom of Information Act asking the following:

Please provide the total number of offences recorded as Production of or being concerned in the production of a controlled drug (Class A) (092/41; Misuse of Drugs Act 1971, s.4(2)(a)) between 1 January 2024 and 1 January 2026.

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

The request name and HO class given are different

- 092/10 - Production or being concerned in production of a controlled drug - Cocaine
- 092/11 - Production or being concerned in production of a controlled drug - Heroin
- 092/12 - Production or being concerned in production of a controlled drug - LSD
- 092/13 - Production or being concerned in production of a controlled drug - MDMA
- 092/14 - Production or being concerned in production of a controlled drug - Crack
- 092/15 - Production or being concerned in production of a controlled drug - Methadone

However:

- 092/41 - Supplying or offering to supply a controlled drug - Class B Cannabis and cannabis resin

Police Forces in the United Kingdom are routinely required to provide statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons the figures given relate to

information from the specific recording system of Gloucestershire Constabulary and should not be used for comparison purposes with any other response you receive.

Please note that our systems are designed to record information for policing purposes and the investigation of crime and not to extract statistical information. Accordingly, whilst we endeavour to extract relevant data within the time limits of the Act, any data supplied is subject to these limitations.

A search was completed between 01/01/2024 and 01/01/2026 for all of the above offences which gave the results:

If you are not satisfied with this response or any actions taken in dealing with your request, you have the right to ask that we review your case under our internal procedure. Please note that a request for an internal review must be made within 20 working days of the response to your original request.

If you decide to request that such a review is undertaken and following this process you are still unsatisfied, you then have the right to direct your complaint to the Information Commissioner for consideration.
