- C. A Speed Awareness Course being declined by the driver (if recorded)
- D. A Conditional Offer of Fixed Penalty (Fixed Penalty Notice) being issued
- E. A Conditional Offer of Fixed Penalty (Fixed Penalty Notice) being accepted
- F. Cases referred to court / prosecution

Q3. Course Eligibility
