Gloucestershire Constabulary Freedom of Information request FOI_26_0512

On 29/05/2026 you sent an email constituting a request under the Freedom of Information Act asking the following:

1. How many reports of stalking and harassment have you received from January 1st, 2020, to April 30th, 2026?
2. Please can you also provide a breakdown of the gender for who is reporting the offence of stalking and harassment from January 1st, 2020, to April 30th, 2026?
3. Please can you provide the outcome of each of these reports of stalking and harassment between the set dates.
4. Please can the information above be presented in an Excel Spreadsheet.

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Police Forces in the United Kingdom are routinely required to provide statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons the figures given relate to information from the specific recording system of Gloucestershire Constabulary and should not be used for comparison purposes with any other response you receive.

Please note that our systems are designed to record information for policing purposes and the investigation of crime and not to extract statistical information. Accordingly whilst we endeavour to extract relevant data within the time limits of the Act, any data supplied is subject to these limitations.

A search has been completed for all stalking and harassment classed offences which has then been filtered by year and gender. Please note that the "Other Victim" table will include people who do not identify to be "Male" or "Female" but also offences against the state and where a gender has not been recorded.
