On 29/05/2026 you sent an email constituting a request under the Freedom of Information Act asking the following:

I'd be immensely grateful for disclosure of the following information under the Freedom of Information Act.

Please provide the total FTE headcount of officers or police staff at your force with specific responsibility for economic crime offences as defined in Schedule 11 of the Economic Crime and Corporate Transparency Act 2023, including fraud and money laundering. Please provide this information for each year in the previous 5 years.

If possible within the cost threshold, for the same time period please also provide a breakdown of the different roles within this FTE headcount, including the number of financial investigators.

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Following receipt of your request, one of the Constabulary's subject matter experts undertook a search for the data you requested. The information they have shared is presented below.
