Gloucestershire Constabulary Freedom of Information request FOI_26_0557

On 10/06/2026 you sent an email constituting a request under the Freedom of Information Act asking the following:

I would like the following information.

How many burglaries or attempted burglaries in the GL52 postcode have been reported to police since 1st January 2020.

How many successful convictions have there been relating to these burglaries and attempted burglaries.

Under the Freedom of Information Act 2000 s1, I can confirm that Gloucestershire Constabulary holds some relevant information.

Police Forces in the United Kingdom are routinely required to provide statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons the figures given relate to information from the specific recording system of Gloucestershire Constabulary and should not be used for comparison purposes with any other response you receive.

Please note that our systems are designed to record information for policing purposes and the investigation of crime and not to extract statistical information. Accordingly whilst we endeavour to extract relevant data within the time limits of the Act, any data supplied is subject to these limitations.

A search was completed for all substantive burglary offences between 01/01/2020 and 31/05/2026 which was then filtered to only show offences that had taken place with a "GL52" postcode. This gave the following data;
