- 2) If any community police hubs have been closed in the last five years, please provide their location and the date they closed.
- 3) Please state the number of reports filed at each hub in each of the last five calendar years.
- 4) Please provide the number of these reports received at each hub that were "crimed" by being recorded as an offence in each of the last five calendar years.
- 5) Of these "crimed" offences reported at each hub please provide a breakdown of the offences recorded by Home Office recording code for each of the last five calendar years.
- 6) Of these "crimed" offences reported at each hub please provide a breakdown of offences by outcome (such as a charge/summons or no suspect identified, or if investigations are ongoing) for each of the last five calendar years.
